SBA Disaster Loans

The US Small Business Administration is making up to \$2 million in low-interest loans, plus advances of up to \$10,000 (does not need to be repaid), available to qualified businesses affected by the pandemic response. Apply for assistance today at: https://covid19relief.sba.gov/

Paycheck Protection Program

Eligible small businesses, self-employed, and contractors may qualify for a loan up to \$10 million (based on 8 weeks prior average payroll plus 25%) to retain and pay employees. Loan payments are deferred for 6 months, and if you maintain your workforce, SBA will forgive the portion of the loan proceeds used to cover the first 8 weeks of payroll and certain other expenses following loan origination. SBA Debt Relief

The SBA will pay principal and interest on new 7(a) loans through Sep 27, 2020. If you have an existing 7(a) loan they will pay principal & interest for the next 6 months. The 7(a) program offers up to \$5 million to eligible small businesses for purchasing land/buildings/equipment/fixtures; lease-hold improvements; refinancing debt for compelling reasons; seasonal line of credit; or inventory. California Capital Access Program

CalCAP is a loan loss reserve program which may provide up to 100% coverage on losses as a result of certain loan defaults. Individual borrowers are limited to a maximum of \$2.5 million enrolled over a 3-year period. Find out more here: https://www.treasurer.ca.gov/cpcfa/calcap/sb/brochure.pdf
